

If any error found, then Trust Bank PLC. may reject the offer. 22.3 The financial offer shall be accompanied by a forwarding letter on the bidding Firm's Letter Head Pad clearly stating the subject line, grand total amount and date. 22.4 In the case The Unit Prices Imprinted in the BOQ, Bidder shall not alter or overwrite the imprinted unit price. 22.5 Financial Offer should be valid for at least 06 months (180 days) from the date of tender opening. 22.6 BOQ rate of items in your offer must be including Tax and excluding VAT. 22.7 Price must be included Tax, product cost, delivery cost, labor cost and all other related costs. 22.8 Tax will be deducted from the final bill after assessment as per Govt. rules.
